

Udny Community Fund

Terms and Conditions



Once an offer of grant from the Udny Community Fund has been accepted, the total amount is committed and is unavailable within the Udny Community Fund to other applicants. Careful management of committed grants and claims are therefore essential.

All applicants should read these terms and conditions before applying to the Udny Community Fund.

Grant Conditions

Grants, or any part of the grant, must be used only for the purpose(s) as set out in the Successful Grant letter.

Grants are awarded from charitable funds and can only be used for purposes consistent with Scottish Charity Law.

The Successful Grant letter must be signed and returned to Udny Community Trust Company (UCTC) within one month or it will be withdrawn.

UCTC may extend this time limit subject to agreement. However, UCTC reserves the right to withdraw the offer of grant if necessary.

Grants will not be awarded in advance unless prior agreement has been reached with UCTC. Advance grants will only be available in very limited circumstances.

Grants can be claimed in stages by prior arrangement, and this must be discussed with the Development Officer.

Grant claims must be made by the completion and submission of the Udny Community Fund Grant Claim form. The amount being claimed must be clearly recorded on the Grant Claim form. This is particularly important if the claim is for less than the full amount committed as unclaimed grant monies will be reallocated back into the Udny Community Fund.

The names and contact details of two members of a group or organisation must be provided on all stages of the process.

Evidence of expenditure must be provided to support the Grant Claim.

Acceptable forms of evidence include:

- ✓ Invoice/s from supplier.
- ✓ Receipt/s.
- ✓ Order confirmation/s.
- ✓ Project cost breakdown. Supported by evidence such as relevant bank statement, payroll records etc. Revenue funding only e.g., projects such as supporting a youth worker. We need to verify that the person's wage or part wage has been paid in accordance with the Grant Conditions.
- ✓ Where offer of grant is subject to a project progress report, this must also be submitted with the Grant Claim form.

Where a grant is not, or will not be, claimed within twelve months from the date it was offered, notification of this must be given in writing to UCTC otherwise the grant commitment will lapse. Any unused portion of the grant must be returned to UCTC.

You can ask to change the way you spend some of the grant money committed. You should contact the Development Officer to discuss any changes in advance. No changes will be agreed if they are not consistent with charitable purposes

as defined by the Office of the Scottish Charity Regulator.

If your project changes in a significant way or you cannot use all or most of the grant for its original purpose, you must contact the Development Officer as soon as possible.

Your grant will normally be paid by BACS payment. If you would like to discuss alternative arrangements such as direct payment of suppliers, please contact the Development Officer in advance.

Applicants must have a valid group / organisation bank account as no payments will be made direct to an individual member.

Publicity

The Udney Community Fund and UCTC must be acknowledged:

- ✓ On all printed publicity materials such as leaflets, brochures etc.
- ✓ In information given to the press and media i.e., in any press releases.
- ✓ On any website or social media content related to the project or activity funded.
- ✓ In a permanent form on or in any community facility improved with funding from the Udney Community Fund (*this must be discussed with the Development Officer*).
- ✓ In any reports or presentation on the project or activity.
- ✓ In any other type of publicity featuring the project.

The UCTC logo is available in a variety of formats and can be requested from the Development Officer.

Monitoring

A monitoring report must be submitted to UCTC **within 12 months** of the Udney Community Fund grant being awarded.

The form of this report is flexible, but it must demonstrate the impact of the funding in relation to the purposes stated in the Successful Grant letter.

Reports prepared for other funders may be accepted as long as they fulfil the conditions listed above.

Monitoring information must also clearly state the full actual cost of the project. If this is not included in the report it must be separately confirmed in writing.

If the project is not complete within 12 months of the grant being awarded, an interim report must still be submitted and should be discussed with the Development Officer.

Any publicity material (see above) should be included with your report.

Advice on how to report can be sought from the Development Officer.
